 - Develop and implement safe work practices for engineering and manufacturing processes.
 - Regularly review risk control measures to ensure effectiveness.

4. Emergency Preparedness

- Maintain clear emergency procedures, including fire evacuation plans and first-aid arrangements.
- Conduct regular emergency drills and training sessions.
- Equip premises with first-aid kits, fire extinguishers, and clear signage.
- Display emergency contact numbers prominently.



5. Training and Awareness

- Provide health and safety induction training to all new employees.
